DIRECTORS' REPORT

FOR THE YEAR ENDED 31 MARCH 2011

The directors present their report and financial statements for the year ended 31 March 2011.

PRINCIPAL ACTIVITIES

The principal activities of the company during the period were to improve the performance of Great Britain's (GB) elite athletes together with developing junior and cadet athletes. This includes the preparation of GB teams to compete in European, World and Olympic Games through UK and overseas based training. Junior and Cadet Team development was facilitated by UK based training in preparation of major international completions.

Sport Taekwondo UK Ltd also provides the exposure for UK and International athletes to competitions based in the UK via the provision of the BTCB National Championships and the British International Open Championships.

BUSINESS REVIEW

The directors are pleased to report that the company has returned to a net asset position at 31 March 2011. The company will continue to aim for small surpluses over the coming years in order to build reserves, whilst taking into account the cyclical nature of our activities, particularly in the immediate lead up to the Olympic Games.

GOING CONCERN

At 31 March 2011, the balance sheet shows an accumulated surplus of £4,884. The directors will monitor closely the cash flow forecasts and the projections for the following year, which currently indicate that the company will maintain a surplus for the year to 31 March 2012. On this basis, the directors are satisfied that the accounts for Sport Taekwondo UK Limited should be prepared on a going concern basis.

DIRECTORS' RESPONSIBILITIES STATEMENT

They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention of fraud and other irregularities.

1. ACCOUNTING POLICIES

The financial statements have been prepared in accordance with applicable accounting standards and the accounting policies set out below.

Basis of preparation of financial statements

The financial statements are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

Income

This comprises grants, donations and sponsorship.

Deferred grants

Grants are credited to income in order to match expenditure in the year to which they relate.

Tangible fixed assets and depreciation

Tangible fixed assets are stated at costs less depreciation. Depreciation is provided at rates calculated to write off the cost of fixed assets less their residual value, over their expected useful life on the following basis:

Gym refurbishment – straight line over three years

Operating leases

Rentals payable under operating leases are charged against the income and expenditure account on a straight line basis over the lease term.
